High Speed Two (HS2) is the new high speed railway for Britain. Initial works on Phase One of High Speed Two (HS2), from London to the West Midlands, have now started.

We will be carrying out land surveys in your area as part of our preparation works. This will involve traffic restrictions at three separate locations (see map below).

- Fosse Way – south of Welsh Road junction
- The junction at Long Itchington Road
- The junction at Welsh Road

These surveys will be carried out from **Monday 13 August**, and are expected to take three days. Controlled temporary traffic restrictions using portable traffic signals will be in place on each day from **9.30am**, with restrictions lifted and the road fully re-opened by **3.30pm**.



We'll be carrying out these surveys to gather data at and above ground level, to map and identify the contours of the ground. These surveys will enable us to complete the design of a new roundabout on the Fosse Way to replace the junction at Welsh Road. A temporary roundabout will also be constructed at the junction with Long Itchington Road.

Traffic restrictions

- Traffic restrictions will be in place for three days from **Monday 13 August** between **9.30am to 3.30pm**.
- Our contractors may be on site for up to one hour beforehand and afterwards to set up and close-down the works.

What to expect

- Some noise from the site during working hours.
- Small increase of vehicles travelling to and from site.
- Some minor disruption to traffic.

- Inform you in advance of any changes.
- Keep all sites safe and secure.
